JOB TITLE: Financial Examiner V - Thrift

JOB DESCRIPTION: Acts as examiner-in-charge of examinations in nonproblem institutions with asset size of less than one billion dollars. Acts as examiner-in-charge of smaller institutions with a moderate level of problems, without on-site supervision. Analyzes overall institution condition. Recognizes regulatory noncompliance and substantial internal control weaknesses. Manages timely completion of all examination areas. Responsible for final examination report content. Has broad latitude in the exercise of independent technical judgment and is responsible for training and assisting other examiners.

EXAMPLES OF WORK PERFORMED:

- ◆ Interpret and apply regulatory policies, procedures, laws and regulations.
- ◆ Analyze areas of concern and personnel needs for upcoming examinations.
- ◆ Act as examiner-in-charge of large nonproblem institutions or small problem institutions, without supervision; act as examiner-in-charge of large problem institutions under supervision.
- ◆ Orally present examination findings to senior management and board of directors.
- ◆ Prepare written examination reports as prescribed by departmental guidelines.
- ◆ Provide supervision, training and evaluation of other examiners.
- ◆ Conduct trust or other limited scope specialty examinations.
- ◆ Conduct credit review and analysis involving larger, more complex credit relationships.

GENERAL REQUIREMENTS:

- ◆ Graduation from an accredited four year college or university with major course work in business, finance, economics, or accounting, with a minimum of nine hours in accounting required.
- ◆ Five years of significant experience in financial institution auditing/examining, including supervision of subordinates and making presentations to senior management and directors.
- ◆ Extensive knowledge of financial institution fundamentals and both state and federal regulatory environment. Work experience in a financial institution is desirable. Specialized knowledge or designations in real estate appraisal or capital markets also a plus.
- ◆ Certified Public Accountant, Certified Internal Auditor, or FDIC Commissioned Bank Examiner designation a plus.

KNOWLEDGE, SKILLS AND ABILITIES:

- ◆ Well developed supervisory skills.
- ◆ Excellent written and verbal communication skills, including the ability to assist with training less experienced or lower level examination staff.
- ◆ Personal computer proficiency, preferably with both word processing and spreadsheet software.
- ◆ Knowledge of audit/examination procedures and examination report writing.
- ◆ Extensive knowledge of state and federal statutes and regulations and Departmental policies.
- ◆ Good analytical abilities; ability to develop and modify work procedures to improve efficiency.
- ◆ Ability to meet deadlines, handle multiple tasks and work independently with moderate supervision.
- ◆ Must possess valid Texas driver's license and may travel up to 80%.

- ◆ The position may require additional work hours including evenings, weekends, and/or holidays to meet deadlines.
- ◆ The job posting in no way states or implies that the duties listed above are all inclusive. Employees are required to perform other duties as assigned.
